



## Choreography Application & Guidelines for Fall 2017 Concert

Please send your completed application form and supporting materials to Moving Collective. The application deadline is July 19, 2017 for the Fall 2017 concert.

1. Application (Can be downloaded at [www.movingcollective.com](http://www.movingcollective.com) and appears at the end of this letter)
2. Work Sample  
Please submit a links to a recent performance-quality video of the work you wish to present that is on YouTube or other similar websites.
  - If there is a specific work excerpt, please note the times. If the choreographer is performing in the work, please identify.
  - If you do not have a recording of the work you propose to show, submit a link to a performance-quality video of another work and note on the application form that the recorded piece is not the proposed work.
  - Do not submit promotional montages of many works.
  - You may submit a DVD of your work. Make sure your DVD is labeled with your name or company name.
3. Choreographer's resume (1 page) and/or Company Profile
4. Choreography Application Fee of \$25.00 for each work submitted
5. Email application materials to [moving\\_collective@hotmail.com](mailto:moving_collective@hotmail.com).
6. Only complete applications in the correct format will be considered.

### Important Guidelines:

- ⇒ Please type your applications and submit in requested format. No handwriting or photocopy submissions.
- ⇒ Artists must be available for all dates of mandatory rehearsals and performances. Artist must also meet all deadlines listed in calendar.
- ⇒ Each choreographer/company may submit up to TWO works for consideration in each concert (each work requires separate complete application forms and videos links).
- ⇒ Length: Group piece must be 8-20 minutes in length (including set-up and strike) and Solo or duet work must be 7-10 minutes in length (including set-up and strike).
- ⇒ Production needs must be minimal.
- ⇒ DVDs will not be returned.
- ⇒ If your work is selected, you will be notified by email by July 24 for the Fall 2017 concert.
